THE HON PETER J. RIORDAN K.C. - Curriculum Vitae

The Honourable Peter Riordan was appointed to the Supreme Court of Victoria in March 2015 and retired in December 2022. From 2018, he was the Principal Judge of the Commercial Court. He was the Judge in Charge of the Arbitration List and served as a Judge nominated by the Chief Justice to manage the Technology, Engineering and Construction List.

He was appointed silk in 2003 and served as President of the Australian Bar Association in 2009-10 and Chairman of the Victorian Bar Council in 2007-08.

His practice at the Bar until his appointment was principally in commercial litigation and he had extensive experience as a mediator and as an arbitrator (including International Arbitrations). A list of reported cases in which he appeared or presided is Attachment 1. His judgments relevant to the law of arbitrations are listed in Attachment 2.

He was the Supreme Court of Victoria's representative on the Australian Centre for International Commercial Arbitration Judicial Liaison Committee. He was the chair of the panel for a session on 'Developments in Energy/Resources/Major Projects Disputes' at ACICA's annual conference on 18 October 2021 in Sydney.

In 2023 he was appointed as an Adjunct Professor of Law at the ACU.

He has acted as a mediator in excess of 1,000 mediations throughout Victoria and interstate. Since his retirement from the bench, he has been listed by Doyles in the best mediators in Victoria. He has been involved in the training of mediators and has published articles and conducted seminars on mediation and commercial litigation issues as set out in Attachment 3:
